
# LOUISIANA WATERSHED INITIATIVE

## WHAT DOES THE PROGRAM DO?

This three-year grant program is designed to help the state's eight provisional watershed regions build staff capacity for regional watershed management, as well as provide technical assistance to municipal partners. In each watershed region, the primary goal is to establish a long-term entity—a watershed coalition—responsible for regional watershed management activities that align with LWI's long-term resilience goals.

\$400,000 grants awarded per region

The state awarded \$400,000 grants to each watershed region to support staff capacity and watershed coordination efforts.



In August 2019, the Council on Watershed Management recognized eight watershed regions to coordinate regional flood mitigation efforts organized around watershed boundaries.

PROGRAM GOALS

- Form one-year regional steering committees, which will develop work plans and ultimately recommend and implement long-term watershed coalitions.
- Ensure transparent, public decision-making processes based on data and science and using watershed models for project planning and development.
- Establish a long-term

- Support higher development standards on a regional scale, advancing regional flood risk reduction.
- Develop and maintain a regional inventory of flood risk reduction projects to evaluate cross-jurisdictional impacts and advance regional capital improvement planning.
- Establish long-term capacity and funding to continue watershed coordination beyond the life of the program.

# Unprecendented & Transparent Local Engagement

#### **EOUITABLE & DIVERSE REPRESENTATION**

RSC membership reflects the demographic diversity and interests of each region. Committee members include a mix of watershed professionals, such as floodplain managers and engineers, as well as community representatives drawn from diverse backgrounds, some of whom have strong ties to local institutions.

#### ADVANCING REGIONAL FLOOD RISK REDUCTION THROUGH CAPITAL IMPROVEMENT PLANNING



A capital improvement plan, typically created by a local or regional planning district that delivers a variety of federal, state and local services, helps organizations make good budgeting decisions for large projects and purchases. Each watershed region completed a project inventory so all regional steering committee members could see the universe of project needs and strategize about aligning capital improvements across jurisdictional boundaries. Multi-jurisdictional coordination is a best practice that can advance comprehensive flood risk reduction at a regional watershed scale.

## STANDARDS SET BY THE STATE, CUSTOMIZED BY REGIONS

The RCBG program consists of partnerships between the state and regions, in which leadership roles are shared and collaborative, making consensus-building possible.
